

# RESOLUTION 2018-05

SUBJ: DELINQUENT FEES CERTIFICATION FOR COUNTY COLLECTION

RE: CRS 32-1-1101

A RESOLUTION CERTIFYING DELINQUENT WATER AND/OR SEWER ASSESSMENTS FOR COLLECTION BY THE LA PLATA COUNTY TREASURER FOR THE FOREST LAKES METROPOLITAN DISTRICT, COLORADO.

WHEREAS, The Forest Lakes Metropolitan District Board of Directors has the authority to adopt resolutions necessary for the governing and management of the District, for the execution of the powers vested in the District and for carrying into effect the provisions of Article I of Title 32, CRS, as amended to promote the health, safety, prosperity, security and general welfare of the inhabitants of the Forest Lakes Metropolitan District and of the people of the State of Colorado, and

WHEREAS, The Forest Lakes Metropolitan Board of Directors has specific Common Financial Powers concerning the collection of Delinquent Fees and Charges as provided in CRS 32-1-1101, as amended, and

WHEREAS, The Forest Lakes Metropolitan District Board of Directors has determined that certain delinquent fees, rates, tolls, penalties, charges, or assessments made or levied solely for water, sewer, or water and sewer services exist, and

WHEREAS, The Forest Lakes Metropolitan District Board of Directors has provided proper notice to the affected parties, including the property owners.


NOW THEREFORE, be it resolved by the Board of Directors of the Forest Lakes Metropolitan District that in order to provide a continued collection effort of accounts receivables the fees for water, sewer, or water and sewer services for the attached list of property is hereby certified to the La Plata County Treasurer to be at least six (6) months delinquent and total at least one hundred fifty dollars per account and shall be collected and paid over by the Treasurer in the same manner as taxes are authorized in accordance with CRS 39-10-107, as amended.

## AFFIDAVIT


The undersigned, having first been duly sworn, states as follows:


