

RESOLUTION 2018-08

2019 BUDGET ADOPTION

A RESOLUTION SUMMARIZING EXPENDITURES AND REVENUES FOR EACH FUND AND ADOPTING A BUDGET FOR THE FOREST LAKES METROPOLITAN DISTRICT, COLORADO FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY 2019, AND ENDING ON THE LAST DAY OF DECEMBER 2019.

WHEREAS, the Board of Directors of the Forest Lakes Metropolitan District has appointed Brian Sheffield, Manager to prepare and submit a proposed budget to said governing body at the proper time; and;

WHEREAS, Brian Sheffield, Manager (budget officer) submitted a proposed draft budget to this governing body on October 9, 2018 for its consideration, and;

WHEREAS, upon due and proper notice, published or posted in accordance with the law, said proposed budget was open for inspection by the public at a designated place, a public hearing was held on November 13, 2018, and interested taxpayers were given the opportunity to file or register any objections to said budget, and;

WHEREAS, whatever increases or decreases may have been made in the expenditures, like increases or decreases were added or deducted to or from the revenues or planned to be expended from reserves/fund balances so that the budget remains in balance, as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE Board of Directors of the Forest Lakes Metropolitan District, Colorado:

That estimated expenditures for each fund are as follows:

That estimated revenues for each fund are as follows:

SEWER OPERATING FUND:


