SUBJ: MEETING NOTICES, DESIGNATED PUBLIC POSTING PLACE AND DESIGNATED MEETING

RE: C.R.S. 24-6-401, 24-6-402(2)(c)

A RESOLUTION DESIGNATING AN OFFICIAL PUBLIC POSTING PLACE FOR 24-HOUR (AGENDA) NOTICE OF DISTRICT MEETINGS FOR THE FOREST LAKES METROPOLITAN DISTRICT.

WHEREAS, The Forest Lakes Metropolitan District Board of Directors has the authority to adopt resolutions necessary for the governing and management of the District, for the execution of the powers vested in the District and for carrying into effect the provisions of Article I of Title 32, CRS, as amended to promote the health, safety, prosperity, security, and general welfare of the inhabitants of the Forest Lakes Metropolitan District and of the people of the State of Colorado, and

WHEREAS, the Forest Lakes Metropolitan District is required to comply with the provisions of CRS 24-6-401 Concerning the Open Meetings Provisions of the Colorado Sunshine Act of 1972, and

WHEREAS, On a yearly basis, Forest Lakes Metropolitan District Board of Directors are required to designate the "official" posting place for 24-hour notice of District meetings and other related District business. The primary posting location will be the Forest Lake Metropolitan District's website.

WHEREAS, to comply with the Special District Association's (SDA) requirements for designating the District's website as the official posting location, we are required to also designate one physical location within the District boundaries for 24-hour notice of District meetings in the event of an exigent or emergency circumstance which prevents posting or public access to the online webpage. This secondary location will be: Mail Stop, 257 Alpine Forest Dr., Bayfield, CO 81122.

WHEREAS, a District that posts notices on a website is required to provide the address of the website to the Department of Local Affairs, and this requirement has been completed.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE FOREST LAKES METROPOLITAN DISTRICT, COLORADO:


